(Request for Electronic Transfer of Funds)

Our electronic giving program allows you to contribute to Christian Women's Job Corps® and Christian Men's Job Corps® of Nacogdoches (hereby referred to as CWJC/CMJC®) by way of an electronic transfer of funds from your bank or credit union to our bank account. Here is an easy way to go about accomplishing this.

- Fill out the special authorization agreement below. Funds are electronically transferred to us monthly or semi-monthly. Transfers are made on the 5th and/or 20th of each month.
Attach a voided check from your account to this form, or provide the information required.
Turn in the authorization agreement and voided check to the CWJC/CMJC® office at 902 S.E. Stallings Dr., Suite 4, or by mail to the address below. Allow at least 2 weeks for the transfers to begin. This agreement may be increased, decreased, or terminated at any time by written notification or email. Please allow two weeks to process all requests.
